Survey Discussions


- Three Chord (Frankford, DE)

Freeman Property Coordination


- Anchor QEA has advanced discussions with GMB (Freeman Properties engineer)
- Freeman has been provided dredged material chemical and physical property data
- Multiple conversations regarding geobag layout and agreeable site use to maximize project efficiency and cost effectiveness
- Freeman property site plan approval not anticipated until Q1 2021
 - Confirmed ability to accept material in 2020 and 2021 (into 2022 if needed)
- Memorandum of Agreement (MOA) drafting in progress

Action Items

- Anchor QEA to subcontract surveying work which will be conducted in July 2020
- Anchor QEA to provide cost estimate for developing and permitting upland placement design to be included in Town dredging project
- Additional interim cost evaluations requested by Town (to be provided by Anchor QEA/Tony Pratt)
 - Approximate cost of geobag materials for dewatering
 - Approximate value of sand fill materials being provided to Freeman
- Anchor QEA and Tony Pratt to continue to track funding and partnership opportunities for 2021 dredging project and future Seal Island restoration
- Anchor QEA to provide draft MOA for Town review
