From the Town Manager's Desk

Most of you are aware that the Town of Fenwick Island is a member of the *National Flood Insurance Program (NFIP)* which provides federally backed flood insurance that encourages communities to enact and enforce floodplain regulations. The *Community Rating System (CRS)* is a part of the *NFIP* and provides incentives and tools to further flood prevention practices and requirements.

The goals of the *CRS* are to recognize, encourage and reward by the use of flood insurance premium adjustments, community activities beyond the minimum required by the *NFIP* that reduce flood damage to insurable property, strengthen and support the insurance aspects of the *NFIP* and encourage a comprehensive approach to floodplain management.

Thus, the *CRS* provides insurance premium rate reductions to policy holders in recognition that their community activities work toward these three goals of reducing flood damage, supporting the insurance part of the *NFIP*, and pursuing a broad approach to floodplain management.

The Town of Fenwick Island has been rated a Class 9 *CRS* community which provides the Town's flood insurance policy holders a 5% discount on their flood insurance premiums. The Residential Advocacy Committee is diligently working to address the concerns of the community regarding issues that affect the quality of life in our quiet, residential beach town. We are accomplishing goals with the support of very dedicated volunteers on our committee along with other committees and Town Council members. WHY DID THE TOWN VOTE TO BAN LSV'S AND SHUTTLES?

Prohibited since 2000, the use of Low Speed Vehicles (LSV) again was recently under consideration by the current Town Council and the Charter and Ordinance Committee (C&O). This also became a hotly debated issue last summer when it was revealed that previous Council had drafted an ordinance to operate 14 to 18 shuttles along Bunting Avenue.

A review of the ban and the possible impact on road safety was undertaken in November and December of 2021. As a result of this study, the C&O Committee recommended a ban on such vehicles for safety reasons:

• **Delaware State law** forbids the use of such vehicles on dual highways, although LSV's are allowed to cross at intersections and can travel on other roads with speed limits of 35 mph or less.

• The speed limit on Rt. 54 from the first bridge to the traffic light on Rt. 1 is 35 mph. Therefore, LSV's could run from Rt. 54, cross Rt. 1 at the light, and then continue into Fenwick along Bunting Avenue, which is the only north/south road that LSV's could use in the town. As such, Bunting would become a gateway road to the beach for LSV's from other communities.

• Unofficially known as "Fenwick's Boardwalk," Bunting Avenue is a favorite place for pedestrians and bicyclists, which is so noted in Fenwick's state-mandated 2017 Comprehensive Plan that prioritizes pedestrian safety for a "walkable" community.

• Allowing LSV's and shuttles would limit their use to other residential streets without connecting north/south roads, thus endangering pedestrians in a town without sidewalks.

• **Safety studies** clearly demonstrate the catastrophic results for shuttle passengers when LSV's collide with regular vehicles. Pedestrians also would be on the losing end of any impact with a shuttle.

• Allowing one person or business to operate a LSV would legally require the Town to permit everyone to have an equal opportunity.

• The use of shuttles cannot be "grandfathered in" because this is a traffic ordinance.

While individual Council Members empathize with LSV supporters, all seven voted unanimously to ban shuttles at the April 4th meeting because Fenwick is the wrong community for LSV's to operate safely.



BEACH COMMITTEE UPDATE

Summer Bonfire This is a fun family activity that raises funds for Fenwick Island Beach Patrol. The date is set for 7/2/2022 from 7-11pm. Please come out to support Fenwick's finest.

Beach Dune End Trash Enclosures– Public Works is working on the beach dune end trash enclosures for Dagsboro, James and Atlantic Streets. They will be completed and installed before the summer season begins. The schedule for trash pick up for the beach ends only will be Monday, Wednesday and Friday during the summer season. Residential trash pickup has been changed to Monday's and Friday's. Residential recycling pickup has changed and will now be on Thursday's. We hope you like the new beach end trash/recycle can enclosures as it aids in keeping our beach ends clean and tidy.

Beach Replenishment– Fenwick Island is tentatively on the list for beach replenishment, however, we have been told that there is a wait due to pending funding by the Federal government.

Towels on Bannisters– Last fall some residents had concerns regarding this matter and investigation shows that no neighboring towns have ordinances banning towels on bannisters except Henlopen Acres. Henlopen Acres is a historical and exclusively residential (no commercial entities) which makes it different than our Fenwick community. This, in addition to the challenge of enforcing a mandate for no towels on bannisters, makes it untenable for Fenwick Island. It is my recommendation that we not pursue an ordinance like this.
