The current version of the Code categorizes violations of several chapters as criminal misdemeanors. Violations of the following chapters may be better suited to receive a civil designation:

- Animals Ch. 48.
- Beaches Ch. 52.
- Boating Ch. 56.
- Building and Utility Construction Ch. 61.
- Buildings, Numbering of Ch. 65.
- Hazardous Materials Ch. 95.
- Licensing Ch. 100.
- Lighting Ch. 102.
- Noise Ch. 107.
- Sanitation Ch. 127.
- Signs Ch. 135.
- Vehicles and Traffic Ch. 153.
- Zoning Ch. 160.

Each of these chapters could be modified to identify that a violation of that chapter is a civil violation. Any reference to a specific penalty or other form of enforcement could be eliminated within the given chapter and could be linked to and interconnected with a newly created Chapter 161, which will allow the individual to readily determine the enforcement mechanism or fine applicable to his or her specific violation.

Below please find the enforcement mechanisms identified throughout the Code and the chapters in which each can be located.

A newly established Chapter 161 could list these civil enforcement mechanisms and describe the process required for each. All civil violations identified in the Code (revised or otherwise) could be linked to and interconnected with Chapter 161.
