#### 1. Discuss/approve minutes from meeting held July 18

## 2. Discuss and finalize any recommendations for committee member training or materials/checklist

From 7/18 meeting...Natalie would like all committee members to receive FOIA training. They should also be given a checklist of items that can be pulled from the matrix. Ann noted that we should emphasize the availability of Zoom for committee members.

Susan said the committees are the drivers behind the implementation of the Comprehensive Plan. The commission has reviewed the questionnaire from the committee chairs and has been forwarded to the Council. The purpose of the training is education that will allow for better leadership. Susan suggested creating a document explaining Robert's Rules of Order, quorum expectations/needs, FOIA and understanding the Comprehensive Plan. Lori added the staff has handbook templates that can be used. The commission decided that all committees should be included.

#### Discussion:

Lisa suggested just the chairs being trained and passing information onto committee members.

Ann said each year there should be a committee kick off meeting prior to the first committee meeting including defining working group or subcommittees, FOIA and meeting invite response.

Susan stated we will be asking for the second half of the committee year report from the chairs, at the end of September.

As the commission moves forward through this first year of Implementation, I suggest each committee member has a packet that includes basic committee educational information and the committee matrix.

Ann added there are some things on the matrix that are not in the right place/committee. Susan asked everyone to look at the matrix and be prepared to discuss the items that either don't quite fit where we put them and or need to move to different committees at the next meeting.

The kickoff meeting should take place in early October.

Lisa shared an info gram, "Quick Guide to Robert's Rules of Order" that could be edited and inserted into the committee packets.

AMENDED MOTION to create a folder for committee chairs containing a matrix checklist, an explanation of Robert's Rules of Order and an explanation of FOIA responsibilities.

Ann suggested each liaison should look at their individual committee's matrix as opposed to looking at the entire matrix. Natalie feels the commission should review the matrix as a whole. She suggested comparing each committee's mission statement to the matrix to determine if a new mission statement needs to be created. Natalie said it's up to the Planning Commission to make recommendations to the Council as to how committees should move forward along with the matrix. The committees are created to serve the town's functions which are directed by the Council. It's important to make sure that all committees are going in the right direction for the town. Natalie feels meetings could be run a little tighter. The goal is to link committees to the 10-year plan to be less reactionary and more forward thinking.

**New business:** Natalie said we need to fill Lisa Lange's place on the commission. Ann added that Lisa's technology expertise has been invaluable for the commission and her replacement should have similar skills.

Lois Twilley's seat expires this year. Natalie has asked Lois if she would like to remain on the Planning Commission. Lois has agreed to stay on.
